Consumer Fireworks Sales Permit Application

Fireworks Permit (Consumer Fireworks)

The sale and use of Consumer Fireworks is permitted in the Town of Midland on listed days within by-law 2024-33. For the use or sale of fireworks outside of the permitted day, it must first be approved by the Midland Fire Department Fire Chief or designate, the resident must obtain a Fireworks Permit from the Town, and follows the Town's Fireworks by-law 2024-33. For display event fireworks separate approval from the Town of Midland Fire Chief is required separate from this permit.

Violation of the terms of the permit as it pertains to the Town's Fireworks by-law 2024-33, could result in a fine and the permit may be revoked.

There is no cost for a one time use or sales Fireworks Permit. Permits are valid for the listed sales time frame only upon purchase.

Fireworks permits will only be issued to property owners or licensed event operator. If the resident is not the property owner, a written authorization from the property owner is required.

Accompanying this application, the following information is required to be sent to fireprevention@midland.ca:

- **The dates for the proposed sales.**
- **A list of what is being sold and the quantities.**
- **A site plan showing where the fireworks will be stored and how.**

Personal information contained on this form is collected under the authority of The Municipal Freedom of Information and Protection of Privacy Act and will be used for the purpose of issuing this permit and for record-keeping purposes.
